

ORDINANCE NO. 14-8

AN ORDINANCE INCREASING THE FEES FOR
BASIC LIFE SUPPORT (BLS) AND ADVANCED LIFE SUPPORT (ALS)
AMBULANCE SERVICES

WHEREAS, Section 13.09 of the Municipal Code provides for fees for ambulance service; and

WHEREAS, the Committee of the Whole of the Village Board of Trustees has determined that an increase in basic life support ambulance fees is warranted upon review of service costs.

NOW, THEREFORE, the Village Board of the Village of Hales Corners, Wisconsin, do ordain as follows:

SECTION 1: Section 13.09 of the Municipal Code of Hales Corners, Wisconsin is hereby repealed and recreated as follows:

"13.09 AMBULANCE FEE. The Village Clerk is hereby authorized and directed to collect fees for ambulance services performed by the rescue squad of the Fire Department as follows:

Basic Life Support (BLS) Charges:

BLS Run Charges: \$550.00 - Residents of the Village of Hales Corners
\$700.00 - Non-residents of the Village of Hales Corners
BLS Support Disposables: \$ 77.00 - Oxygen Administration
\$ 77.00 - Supplies
BLS Support Mileage: \$ 18.00 - Per Loaded Mile

Advanced Life Support (ALS) Charges:

ALS Run Charges: \$300 - ALS service and/or treatment without transport.
\$700.00 – ALS service with transport, level ALS 1 (Resident)
\$850.00 – ALS service with transport, level ALS 1 (Non-Resident)
\$791.93 – ALS service with transport, level ALS 2 (Resident)
\$936.94 – ALS service with transport, level ALS 2 (Non-Resident)

ALS Services and Procedures: \$103.00 – Defibrillation
\$ 62.00 – IV and Supplies
\$ 77.00 – Intubation
\$ 82.00 – ALS Supplies
\$ 77.00 – Oxygen and Supplies
\$ 18.00 – Loaded Mileage (per mile)
\$103.00 – EKG
\$123.00 – E-Z IO
\$128.00 – Spinal Immobilization
\$ 3.00 –Triage barcode wristbands
\$ 46.00 – CPAP

Drugs, IV-TECH Level: \$ 33.00 – Group-1 (Albuterol, Amioderone [30 mg], Atropine, Benadryl, Heparin Sodium by IV, Lasix, Lidocane, Ativan, Versed, Sodium Normal Saline, Solumedrol [up to 40 mg], Terbutaline, Diazepam, Dextrose 50%, Nitro Spray SL, Normal Saline [capped], D50 D5w, Aspirin)

\$ 38.00 – Group-2 (Calcium Chloride, Epinephrine [IM or IV, not by Epi-pen], Dopamine, Lidocaine, Sodium bicarbonate)

\$ 49.00 - Group-3 (Morphine, Narcan, Normal Saline, Fentanyl)

\$ 92.00 – Glucagon
\$ 98.00 – Epinephrine by Epi Pen

All monies received shall represent reimbursement to the Village and shall be paid into the Village general fund as part of the general Village revenue."

SECTION 2: The terms and provisions of this ordinance are severable. Should any term or provision of this ordinance be found to be invalid by a court of competent jurisdiction, the remaining terms and provisions shall remain in full force and effect.

SECTION 3: All ordinances and parts of ordinances in contravention to this ordinance are hereby repealed.
