#### 16.01 DEFINITIONS

(1) **Park: Parkway.**

- (a) Milwaukee County Parks. The terms “park” and “parkway”, whenever used in Chapter 16, unless otherwise stated, shall include the grounds, buildings thereon, waters therein, and any other property which is now or may hereafter be under the control or jurisdiction of the Milwaukee County Park Commission.
- (b) Village of Hales Corners Parks. The term “park” and “parkway”, whenever indicated by Section 16.31 of this Chapter, shall include the grounds, buildings thereon, waters therein, and any other property which is now or may hereafter be

under the control or jurisdiction of the Village Board of the Village of Hales Corners.

- (2) **Person.** The term “person”, as used in Chapter 16 shall include any individual, firm, partnership, corporation, and association of persons, and the singular number shall include the plural.
- (3) **Park Commission: Commission.** The term “Park Commission”, or “Commission”, wherever used in Chapter 16, shall mean the Milwaukee County Park Commission.

## **16.02 PERMIT FOR PUBLIC MEETINGS AND ASSEMBLIES.**

- (1) Public meetings, assemblies, religious services, entertainment, and sporting or athletic events are allowed in parks and parkways, the use thereof and/or facility only by written permit issued by the Director of Parks, Recreation, and Culture or his designee.
  - (a) Application for permits shall be made in writing to the Park Commission and shall state:
    1. The name, address, and telephone number of the applicant.
    2. The name and address of the person, persons, corporation, or association sponsoring the activity.
    3. A description of the activity to be conducted.
    4. The name of the park or parkway and the part thereof for which the permit is requested.
    5. The date of the proposed activity and the hour at which it will begin and end.
    6. The estimated anticipated attendance.
    7. Special needs, i.e., kitchen, utilities, parking, tent, sound, security, and other.
  - (b) A permit shall be issued to an applicant for the facility requested if:
    1. It has not been reserved by other permittees.
    2. The site or facility requested will safely accommodate the anticipated attendance, is appropriate for the activity to be conducted, and the activity will not physically damage the site or unreasonably interfere with general public enjoyment or use and enjoyment by other permittees.
    3. Permittee provides a signed statement, on a form to be provided by the Park Commission prior to issuance of said permit, stating that the permittee will abide by Sections 47.16, 63.01, and 63.02 of the Milwaukee County General Ordinances.
- (2) **Noise.** No person shall use or operate any radio, phonograph, musical instrument, or other (mechanical, electrical sound making, reproducing, or amplification) device in a park or parkway so as to unreasonably interfere with the use and enjoyment of the park or parkway by the public.
- (3) **Interference with Permittees Prohibited.** No person shall in any manner disturb, harass, or interfere with any person or party holding a written permit, nor with any of their equipment or property.
- (4) No permittee shall in any manner disturb, harass, or interfere with any member of the public in the park or parkway nor with any of their equipment or property.

(5) **Parades and Processions.** Parades or processions shall be allowed in any park and parkway only by written permit, issued by the Director of Parks, Recreation, and Culture or his designee, unless they are scheduled for a time which presents a hazard or danger to other users of the parks or parkways. Application shall be in writing and state:

1. The name and address of the applicant.
2. The name and address of the person, persons, corporation, or association sponsoring the parade or procession and the purpose of the event.
3. The name of the park or parkway through which the parade or procession is to pass.
4. The date of the parade or procession, its designated route, and the time it will pass through the park or parkway.
5. The estimated number of vehicles and persons expected to participate in the parade or procession.

**16.03 GAMES AND AMUSEMENTS PROHIBITED EXCEPT IN DESIGNATED AREAS; PERMITS FOR EXCLUSIVE USE.**

- (1) **Prohibited Except in Designated Areas.** No person shall engage in any sport, game, race, or amusement in any park or parkway except upon such portions thereof as may be designated for that purpose, and then only under such rules and regulations as may be established by the Park Commission.
- (2) **Permits for Exclusive Use; Interference with Prohibited.** Permits for the exclusive use of any picnic or play area for any specified date or time may be granted at the discretion of the Park Commission, and no person shall in any manner disturb or interfere with any person or party occupying the ground under such a permit, nor with any of their equipment or property.

**16.04 SALES AND SOLICITATION FOR SALE PROHIBITED WITHOUT PERMIT; DISTRIBUTION OF HANDBILLS, ADVERTISEMENT; REGULATION OF.**

- (1) **Sales and Solicitation of Sales.** No person shall sell, keep, or offer for sale, any tangible or intangible article, merchandise, or thing; nor solicit for any trade, occupation, business, or profession, or for alms, within the park or parkway, without the written permit of the Park Commission.
- (2) **Distribution of Literature.** No person shall post or affix any circular, card, or sign, irrespective of type, in any park or parkway. Distribution of literature or the expression of ideas by signs or placards which interfere with or obstruct the passage or movement of people or vehicles is prohibited.

**16.05 USE OF FIREARMS, FIREWORKS; HUNTING WITH BOW AND ARROW AND TRAPPING; THROWING OF MISSILES; MAKING OF FIRES; DEPOSIT OR BREAKAGE OF TIN CANS, BOTTLES, AND GLASSWARE; PROHIBITIONS.**

- (1) **Use of Firearms and Fireworks; Hunting with Bow and Arrow; Trapping.** No person shall carry, fire, or discharge any gun, pistol, or firearm, nor any rocket, torpedo, or other fireworks of any description, nor shall any person engage in trapping within any park or parkway without a written permit of the Park Commission; nor shall any person

hunt with bow and arrow within any park or parkway. The word “gun” shall include air gun.

- (2) **Throwing of Stones or Missiles.** No person shall throw stones or missiles in or into any park or parkway.
- (3) **Making of Fires.** No person shall make or kindle a fire for any purpose except in places provided therefore, and then subject to such regulations as may be prescribed.
- (4) **Deposit of Tin Cans, Bottles, and Glassware Forbidden Except in Waste Container; Removal of Broken Tin Cans, Bottles, or Glassware.**
  - (a) No person shall deposit any tin cans, bottles, or other glassware, after the same have been used in any place in a park or parkway, except in waste containers provided by the County Park Commission, or except in containers carried by such person for the purpose of removing same from such park or parkway.
  - (b) Any person who breaks a bottle or other glassware in any park or parkway shall immediately pick up the broken pieces and remove same into a park waste container.

#### **16.06 ANIMALS IN PARKS.**

- (1) **Disturbance of Animals on Exhibition.** No person shall injure, molest, or disturb any animal exhibited in the Zoological Garden or in any other area of the park or parkway, nor feed or attempt to feed the same where posted rules prohibit such conduct.
- (2) **Animals Not Allowed in Parks; When; Exception.** No animal, except those placed in the park or parkways by the authority of the Park Commission, and excepting horses when saddled or harnessed and in use for riding for pleasure, driving only on roadways or paths duly designated, and except dogs on leash, as regulated by subsection (3) hereof, shall be conducted into or driven within the parks or parkways or be allowed to remain therein. This, however, does not apply to animals engaged in the construction, maintenance, or operation of the parks and parkway.
- (3) **Dogs Prohibited in Certain Areas. Otherwise Permitted Only When on Leash.** No person having the control or care of a dog shall suffer or permit such dog to enter or remain in a public park or parkway unless it be led by a leash of suitable strength not more than six (6) feet in length, and then only within such areas in parks as have been designated by order of the Park Commission. The Park Commission shall cause signs to be posted in areas wherein dogs are not permitted.
- (4) **Dogs not Permitted in Zoological Gardens.** No dog, whether on leash or not, shall be permitted at any time in the Zoological Garden nor in any other area of a park or parkway where domestic or wild animals are exhibited.
- (5) **Impounding of Dogs, When.** Dogs found running at large within any park or parkway may be impounded by any peace officer or by any employee of the Park Commission.

#### **16.07 FISH; WATERFOWL; GAME BIRDS.**

- (1) **Fish.** No person shall take or attempt to take any fish from, or send or throw any animal or thing into or upon, any of the waters of the parks or parkways; or kill, injure, or

attempt to injure, or unnecessarily disturb the fish in said waters, except with permission of the Park Commission.

- (2) **Waterfowl; Game Birds.** No one shall kill, injure, or attempt to injure, or unnecessarily disturb any waterfowl or other birds or animals, wild or domestic, within any of the parks or parkways. Nor shall any person rob or disturb the nest or eggs of any bird or other animal therein.

#### **16.08 INJURY TO, DESTRUCTION, OR REMOVAL OF PUBLIC PROPERTY.**

##### **(1) Destruction of Property.**

- (a) No person shall climb any tree, or pluck any flowers or fruit, wild or cultivated, or break, cut down, trample upon, remove, or in any manner injure or deface write upon, defile, or ill use any tree, shrub, flower, flower bed, turf, fountain, ornament, statute, building, fence, apparatus, bench, table, official notice, sign, bridge, structure, or other property within any park or parkway.
- (b) No person in any park or parkway shall remove any device for the protection of trees or shrubs, nor shall any such person fasten a horse or other animal next to any tree, shrub, or grass plot, which may become damaged by the action of the animal.

- (2) **Removal of Ice or Sand Prohibited.** No person shall take ice from any stream or lake within any park or parkway, nor remove any sand therefrom or from the shores thereof without a written permit of the Park Commission.

**16.09 USE OF PARKS FOR AIRCRAFT OR PARACHUTE PROHIBITED EXCEPT WITH PERMIT.** No person shall ascend or land with any aircraft, including gliders and parachutes, nor engage in stunt flying or parachute landing in any park or parkway without the written permit of the Park Commission.

#### **16.10 USE OF MOTOR VEHICLES IN PARKS.**

- (1) **Driving Confined to Regular Drives and Parking Area.** No person shall operate or drive any motor vehicle or other vehicle of traffic or burden upon any part of the parks or parkways except roads, driveways, parking areas, or other areas which have been designated by the Park Commission for vehicular travel.
- (2) **Vehicles for Hire not to Stand in Parks; Exception.** No person shall cause any taxi, bus, limousine, or other vehicle for hire to stand upon any part of the parks or parkways for the purpose of soliciting or taking in passengers or persons other than those carried to the parks or parkways by said vehicle, unless licensed by the Park Commission.
- (3) **Use of Parks by Certain Vehicles Prohibited.** No person shall cause any bus, with or without passengers, nor any cart, dray, wagon, truck, or trailer, or other vehicle carrying goods, merchandise, manure, soil, or any other articles, or solely in use for the carriage of goods, merchandise, manure, or other article, to enter or be driven in any part of the parks or parkways. This section shall not apply to vehicles engaged in the construction, maintenance, or operation of the parks or parkways, nor to buses under permit of the Park Commission.

- (4) **Duty of Vehicle Operators to Comply with Traffic Codes.** It shall be the duty of every person operating an automobile, motorcycle, or other vehicle of traffic or burden within the parks or parkways, to comply with the State, County, and municipal traffic codes, and with all orders, directions, and regulations of traffic officers, or officially displayed on any post, standard, sign, or device installed for the regulation of traffic.
- (5) **Speed of Vehicles.** No vehicle shall be operated on any road or drive in any park or parkway at a speed exceeding 25 miles per hour.
- (6) **Stopping at Intersections of Park Drives or Roadways.** When the County Park Commission has caused certain intersections of park drives or roadways to be marked with “Stop” signs, no person shall operate any vehicle except authorized emergency vehicles over or across such intersections without first bringing such vehicle to a complete stop opposite “Stop” sign.
- (7) **Parking Prohibited in Specific Areas During Specific Hours.** No person shall park any vehicle or permit any vehicle to remain standing on any highway or roadway within the boundaries of County parks and parkways as hereinafter designated in excess of the length of time and between the hours as hereinafter specified in this subsection:
- (a) No parking shall be allowed on any of the park or parkway roads during the hours from 10:00 p.m. to 6:00 a.m.
- (b) Whitnall Park:
1. No parking on the southerly side of the north park road between the first and second intersections on the road leading from West Forest Home Avenue to the Arboretum.
  2. No parking on the southerly side of the north park road between the second intersection southeasterly of Forest Home Avenue and the east end of the drive to the Arboretum Building.
  3. No parking on both sides of the road leading from the north park drive to the Arboretum building.
  4. No parking on the westerly side of the central park road from the second intersection southeasterly of Forest Home Avenue southerly 200 feet to the southeasterly limits of the Family Picnic Area.
  5. No parking on the westerly side of the east park road from the first intersection north of College Avenue to the east end of the drive to the Arboretum Building.
  6. No parking on both sides of the central park road from the first intersection north of College Avenue 1,200 feet northerly.
  7. No parking on both sides of the east park road from South 92<sup>nd</sup> Street northwesterly 700 feet to the intersection of the roads.
- (c) Parking Area. Parking areas in County parks are established for the convenience of patrons while using the facilities of the parks. It shall be unlawful for any person to park, stop, or leave standing any vehicle in any park area in any County park except during the time he remains in the park.
- (8) **Definition of Terms**
- (a) The term “parking” where used in Section 16.10 of the General Ordinances means the standing of any motor vehicle or other vehicle of traffic or burden, whether attended or unattended, upon any highway otherwise than temporarily or while actually engaged in loading or unloading or in receiving or discharging passengers or while standing in obedience to traffic regulations or traffic signals.

- (b) The term “motor vehicle” where used in Section 16.10 of the General Ordinance means a vehicle which is self-propelled.
  - (c) The term “motor go-kart” where used in Section 16.10 of the General Ordinances means a motor vehicle propelled by a cycle type gasoline engine or engines, designated to travel on three (3) or more wheels with a seat for the driver and not exceeding 300 pounds net weight.
- (9) **Posting of Signs.** The County Park Commission shall erect suitable signs on all highways hereinabove restricted as to parking, which signs shall indicate the limitation of no parking and shall indicate that no parking shall be allowed at any time.
- (10) **Parking Area to be Used for Parking Purposes Only.** No person shall operate or drive any motor vehicle in any area designated for the parking of vehicles except for the purpose of parking therein or of maintaining such area.
- (11) **Operation of Motor Go-Karts Prohibited in Parks.** No person shall operate a motor go-kart upon any part of the parks or parkways except in areas which have been designated by the Park Commission for the operation of motor go-karts.
- (12) **Stipulations for Parking Violations; Procedure.** The procedure for persons to whom a summons has been issued by the Hales Corners Police Department shall be in accordance with Chapter 2 of this Code.
- (13) **Regulation of Snowmobiles.**
- (a) Definition. Snowmobile means a motor-driven vehicle designed to travel over a snow surface with an operator or an operator and one (1) or more passengers. Such vehicle shall derive traction from a continuous track-laying device, the periphery of which shall be rubber or metal reinforced rubber but shall not include any block, studs, flange, spike, or other protuberance. The term “snowmobile” shall not mean vehicle driven by an airplane propeller or a vehicle driven by wind action and specifically designed for ice sailing.
  - (b) No person shall be permitted to operate or drive a snowmobile in any park or parkway.

**16.11 REGULATION OF BICYCLE RIDERS.** Riders of bicycles shall comply with the rules for the regulations of other vehicles, as stated in Section 16.10 of the General Ordinances, and in addition thereto shall be subject to the following regulations.

- (1) No person shall ride a bicycle upon the lawns, walks, or foot trails in the parks or parkways.
- (2) Riders shall proceed in the extreme right hand lane of the drives at all times, in single file only.
- (3) Riding crosswise and curving to and fro are strictly prohibited.
- (4) No rider shall take both hands off the handles or ride recklessly in any other manner.
- (5) A bicycle shall not be towed by a rope or otherwise, nor shall any rider hold on to any moving vehicle for the purpose of being drawn along.

- (6) No bicycle shall be pushed upon any park or parkway drive where an adjoining footwalk is available.
- (7) Infants, children, or extra passengers shall not be carried on bicycles in any manner whatsoever.
- (8) Children riding small bicycles, wheels less than 20 inches in diameter, may use the footwalks.
- (9) Wherever possible, bicycles shall be parked in places provided for such purpose.

#### **16.12 HORSEBACK RIDING REGULATIONS.**

- (1) **Riding on Designated Paths Only.** No person shall ride horseback in any park or parkway except upon designated roadways and bridle paths.
- (2) **Hours When Riding is Permitted.** No person shall be permitted to ride horseback in any park or parkway after dark or before daybreak.
- (3) **Unruly Horses Barred.** No person shall be permitted to ride or drive a horse which cannot be held under such control that it may be easily turned or stopped.
- (4) **Reckless Riding Prohibited.** No person shall be permitted to ride or drive a horse in a reckless manner.
- (5) **Pedestrian Right-of-way.** Pedestrians shall have the right-of-way when crossing a bridle path, and whenever groups of people are visible within 300 feet, horses shall be ridden at slow gaits.
- (6) **Compliance with Posted Rules.** Every rider shall comply with all Park Commission rules and signs along the bridle paths.

**16.13 BOATING REGULATIONS.** No person shall, without written permission of the Park Commission, place upon the lagoons, rivers, or any of the waters under the control of the Park Commission, any float, boat, or other water craft, nor land or go upon any of the islands of the lagoons or rivers, nor land or touch with a boat upon any part of the shores not designated as a landing place.

#### **16.14 BATHING AND SWIMMING REGULATIONS.**

- (1) **Swimming Permitted Only at Designated Places.** No person shall wade, bathe, or swim within a park or parkway except at such pools or beaches as are or may be designated for that purpose by the Park Commission.
- (2) **Proper Bathing Attire Required.** No person shall wade, bathe, swim in, or attend at any such pool or beach with out proper bathing attire as prescribed by any rules and regulations.
- (3) **Bathers Restrict to Bathing Areas.** No person dressed in bathing costume shall be permitted in the parks or parkways except in such areas as are designated for bathers by the Park Commission.

- (4) **Tin Cans, Bottles, Etc., Prohibited.** No person shall take any tin can, bottles, or glassware of any kind except eye glasses, into an area designated as a beach or pool for bathers by the Park Commission.

**16.15 FORTUNE TELLING; GAMBLING; PROHIBITED.** No person shall be allowed to tell fortunes or to play or bet at or against any game which is played, conducted, dealt, or carried on with cards, dice, corn, or other device for money, chips, credit, or any other representative of value; nor shall any person be allowed to maintain or exhibit any gambling table or other instrument of gambling or gaming.

**16.16 DISORDERLY CONDUCT; SMOKING; PROHIBITED.**

- (1) **Disorderly Conduct.** No person shall use threatening, abusive, insulting, profane, or indecent language, nor be guilty of conduct that is abusive, insulting, obscene, indecent, or constitutes a breach of the peace.

- (2) **Person Guilty of Disorderly Conduct to be Removed.** No person violating any of the prohibitions enumerated in subsection (1) of this section shall be allowed to remain in any park or parkway.

- (3) **Smoking, When Prohibited.**

(a) No person shall be permitted to smoke or to hold a lighted cigarette, cigar, or pipe in any building where domestic or wild animals are exhibited, nor in any building or section of a building, or in any park or parkway area where officially posted notices so prohibit.

(b) Dropping Lighted Cigars, etc., on Roadway. No person shall throw or drop a lighted cigar or cigarette stub or empty a lighted pipe from an automobile moving along a park or parkway drive.

**16.17 USE OF LIQUOR IN PARKS.** No person shall bring into or drink any spirituous, vinous, malt, or mixed liquors in any park or parkways, except in such areas as designated by the Park Commission, and then only by written permission of the Park Commission, and except at such places as beverages are sold by licensees of the Commission.

**16.18 CARE OF WASTE.**

- (1) **Scattering of Rubbish Prohibited.** No person shall scatter, drop, or leave any piece of paper, rug, tin can, bottle, glass, peanut shells, melon rinds, banana peels or other garbage, dead flowers, or other rubbish in any portion of the parks or parkways, except in the receptacles provided for that purpose.

- (2) **Wholesale Dumpage of Rubbish and Waste Prohibited.** No person shall deposit, dump, throw, or place any earth, rubbish, dust, manure, paper, garbage, or any other refuse matter, or any sand, stone, lumber, or building material, or any substance of any kind, in or upon part of the waters, grounds, or roadways of any park or parkway without written permission of the Park Commission.

**16.19 LOCATION AND CONSTRUCTION OF UTILITY FIXTURES.** The location of all sewers and receivers, gas pipes, water pipes, stopcock boxes, hydrants, lamp posts,

telegraph, telephone, and electric power posts and lines, manholes, conduit, and pumps within any park or parkway shall be subject to the jurisdiction of and control of the Park Commission; and their construction, erection, repair, or relocation shall be undertaken only after written permission is received from said Commission.

**19.20 CUTTING OF PARKWAY CURBS FOR PRIVATE DRIVES; PERMIT REQUIRED.**

- (1) **Curb Cutting Allowed Only with Permit.** No curb, whether stone, concrete, or grass, shall be cut for the purpose of constructing a private driveway across any parkway border nor for any other purpose, without written permission of the Park Commission.
- (2) **Design of Private Paths, Drives, and Roadways Across Any Sidewalk Border Subject to Commission Approval.** The location, width, grade, and construction of all paths, driveways, and roadways across any sidewalk border along any parkway shall be subject to the approval of an constructed only after written permission therefore is obtained from the Park Commission.

**16.21 EXCAVATING IN PARK OR PARKWAY; PERMIT REQUIRED; CONDITIONS.**

- (1) **Permit Required to Excavate.** No person shall open a trench for any purpose, or dig into, or take up, any part of any park or parkway, without the written permission of the Park Commission.
- (2) **Conditions of Permit.** The person to whom such permit is granted shall complete the work within the time specified in said permit, and shall do said work and refill and replace or remove in a substantial and workmanlike manner all material disturbed by him, and shall leave the place where said work was done in as good condition as before said work was begun. No such trench or opening shall be dug in any location or manner which may injure the roots of any tree without the prior written permission of the Commission.

**16.22 CARE REQUIRED IN MAKING EXCAVATION.** Every person, firm, or corporation, who shall receive a permit to open a trench, to cut a curb, or to deposit materials in or upon any park or parkway, shall at all times after such work has been commenced or materials deposited, and until the same has been completed, and until all accumulations of materials resulting from such work have been removed, so guard and protect the same that persons driving or passing along the roadway or sidewalk or in the vicinity of the place where the work is being done, shall not be likely to meet with any accident therefrom; and shall also during the time, from sunset to sunrise, each night while said work is in progress, cause the same to be securely fenced and guarded by a red light or lights placed in a conspicuous position, and so secured that the same shall not be extinguished.

**16.23 CLOSING PARK OR PARKWAY FACILITIES TO THE PUBLIC.** In case of an emergency, or when in the judgment of the Park Commission the public interest demands it, any portion of the parks or parkways or buildings therein may be closed to the public, or to designated persons, until permission is given to return.

**16.24 IMPROPER USE OF PARK FURNITURE.** No person shall lie down upon any bench or table in any park or parkway, nor shall hang, occupy, or use any hammock, excepting those used for placing infants therein.

**16.25 SLEEPING, CAMPING, OR LODGING IN PARKS FORBIDDEN.** No person shall sleep, or camp, or lodge in any park or parkway, except in such places as designated for such purposes, as overnight, or tourist, or trailer camps, and then only subject to the rules and regulations of the Park Commission, governing the use of such areas.

**16.26 INTERFERENCE WITH PARK EMPLOYEES UNLAWFUL.** No person shall interfere with or in any manner hinder any employee of the Park Commission, nor any employee of a contractor while engaged in constructing, repairing, or caring for any portion of the parks or parkways, or while in the discharge of the duties conferred by Chapter 47 of the General Ordinances of Milwaukee County

**16.27 PARK HOURS.** Parks and parkways shall be closed daily between midnight and sunrise except to vehicular traffic moving along streets or roadways and except with the Park Commission publishes or posts different closing hours. No person shall remain in the park or parkways during the hours they are closed.

**16.28 PERMITS; OBLIGATIONS OF PERMITTEES.** All permits shall be issued by a duly authorized employee of the Park Commission in writing and subject to park rules and regulations. The persons to whom such permits have been granted shall be bound by said rules and regulations as fully as though the same were inserted in said permit, and any person or persons to whom such permits have been granted shall be liable for any loss, damage or injury sustained by the Park Commission, or by any person by reason of the negligence of the person or persons to whom such permits have been granted, their servants or agents.

**16.29 LOITERING ON COUNTY PREMISES.**

- (1) To loiter means to remain idle, stand around, sit, or lie, in essentially one location or move about slowly.
- (2) No person shall loiter on County grounds, including buildings, entrances and exits thereto, structures, walkways, and roadways in a manner which:
  - (a) Creates alarm or fear in members of the public, County employees, and County officers for their safety or the safety of public or private property.
  - (b) Molests, harasses, or intimidates any person on County premises.
  - (c) Obstructs offices, lobbies, corridors, stairways, doorways, walkways, roadways, and parking lots as to prevent and interfere with access or free passage by members of the public, County officers, and employees.
  - (d) Interferes with the transaction of business or the performance of duties by County employees or officials.

**16.30 POLICE POWERS IN ENFORCEMENT OF THIS CHAPTER.** Pursuant to the authorization contained in Section 47.30 of the Milwaukee County Rules and Regulations governing parks and parkways, any police officer of Hales corners may without a warrant arrest any offender whom he may detect in the violation of any of the provisions of this Chapter, and take the person so arrested forthwith before a magistrate having competent jurisdiction, and he shall have at all times the right to enter the premises of any building,

structure, or enclosures which may be leased or set aside for private or exclusive use of any individual or group of individuals, for the purpose of arresting violators hereof, and may use all necessary means to attain that end.

**16.31 APPLICATION OF CHAPTER 16 TO VILLAGE PARKS.** The following sections of Chapter 16 of the Village Code shall apply to any facility designated a “park” or “parkway” under the jurisdiction of the Village Board of the Village of Hales Corners and the terms “Park Commission” and ”County Park Commission” as set forth in such sections shall mean “Village Board or its designee”: 16.03; 16.05; 16.06(1), (2), (3), and (4); 16.07(2); 16.08; 16.09; 16.10; 16.11; 16.13; 16.14; 16.17; 16.25; 16.27.

**16.32 PENALTIES.** Any person who shall violate any provision of this Chapter shall be subject to a penalty as provided in Section 19.04 of this Code.
