ORDINANCE NO. 93 – 08 (An Ordinance creating peddler license fees.)		
The Village Board of the Village of Hales Corners do ordain as follows: SECTION 1: Section 11.04(c); Village Code is hereby created to read as follows:		
(c) <u>License fee.</u> At the time of filing the application a license fee shall be paid to the Village Clerk. The license fee shall be the lesser of \$20 per day or \$200 per license year.		
SECTION 1: This ordinance shall take effect and be in force from and after its passage and publication.
